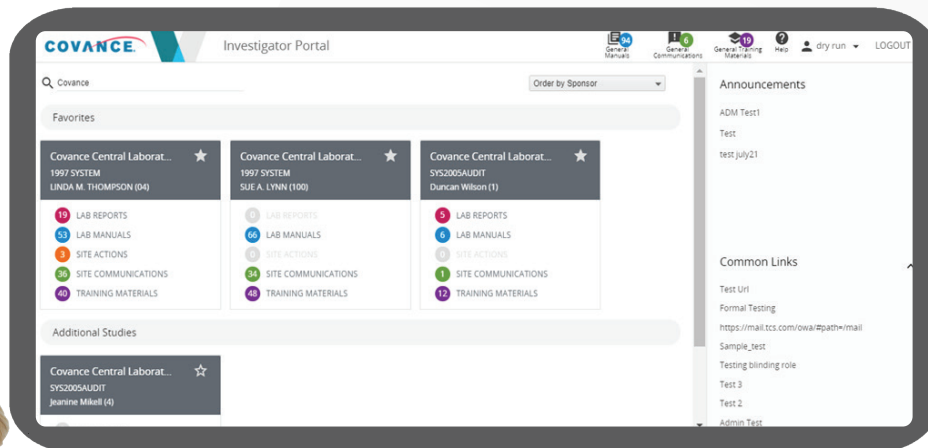

Your investigator team will now have access to the Xcellerate Investigator Portal, which offers an easy-to-navigate dashboard and intuitive user interface.

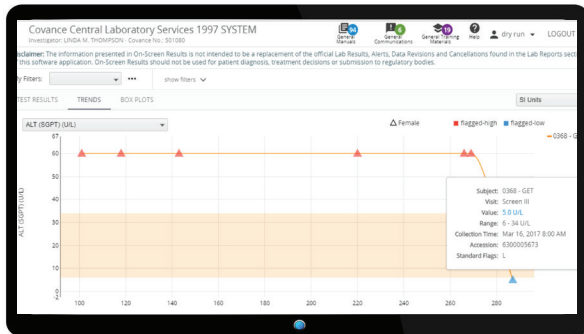
